General Business	 A question was raised as to what happens to a club if the lease is 'handed back'. The understanding is that building must be removed with all costs paid by the club. When the Lines Company replaced all the transformers, they found that the power line to Aorangi needed to be replaced. The cost of replacing power cable is approximately \$100,000. DoC said 'No' to Aorangi using a generator for the period when the cable is renewed. Whanganui Ski Club – Gordon Horsely asked if any clubs were making vaccinations mandatory for 2022 season? i.e. can members attend the club is they are not vaccinated? Gordon is talking to Drs Jackson & Hendy, Auckland University, and will share a paper to the RMCA committee that will be shared with other clubs. Phill Thomas thanked RMCA Council for all the hard work they have done in a very difficult year.
