### RMCA Council Update

We were pleased to welcome 4 new councillors at the RMCA AGM. They are Russell Turnbull (Te Horonuku), Ian Chamberlain (Taupo), Simon Hunt (RSC) & Darian Warburton (Puketoi) to the RMCA Council. These councillors join the RMCA President Phill Thomass (RSC) and the Vice President Debbie Evans (Ngauruhoe Ski Club). We also have long standing councillor- Tony McKenna (Rotorua), Treasurer Kevin Mason (Tararua) and Sheryl Brownlee (RSC) our secretary.

### WHL Application for a Concession to Operate Whakapapa Ski Field

Late last year DoC called for submissions on an application by WHL to maintain and operate Whakapapa Skifield. Submissions closed in early February and the RMCA submitted its support for the WHL application. The RMCA submission specifically stated it supported WHL being granted a concession to operate the Whakapapa ski field in its entirety of 580,000 hectares. The RMCA submission also stated its support of WHL being granted a concession to operate all current lifts and facilities on the Whakapapa Ski Field.

DoC hearings on the WHL application took place at the end of February. Debbie Evans and Russell Turnbull attended the hearing virtually and presented the RMCA submission of support. The timing for an announcement on the granting of a concession to WHL is most likely end of April.

## **Incorporated Societies Act (2022 Act) – Updating Constitutions**

There will be a working session on this at the upcoming RMCA Forum. (See below for the RMCA Forum date)

The 2022 Act is new legislation that replaces the current Incorporated Societies Act which has been around since 1908 (1908 Act). The 2022 Act came into force on 6 April 2022. The 1908 Act continues to apply to all incorporated societies until they register under the 2022 Act.

- Societies can now reregister under the new Act and have until **5 April 2026** to do so.

Reregistering under the 2022 Act means a society must update their rules to comply with the requirements of the 2022 Act and then apply to the Registrar of Incorporated Societies for reregistration.

### What happens if existing societies do not reregister by 5 April 2026?

Any society that does not reregister by the end of the registration period in April 2026 will cease to exist as an incorporated society. That means that the society's committee or board will become a group of individuals who are personally liable for the commitments of the society before it ceased to exist (e.g. debts, liabilities).
